## **MSC Dress-Up Parade Information - Entry divisions & Parade Rules**

- The parade committee separates Queens & Courts from Riding Groups for judging purposes. Your group may stay together if the Queen & Court do not wish to be judged.
- The youth group division will include organized groups such as Boy Scouts, Camp Fire, F.F.A., 4-H, etc.
- If you are not certain of the division in which to place your entry, leave the division to be judged blank. The parade committee will determine the appropriate division if you specify that you wish to be judged on the entry form.
- Please be sure to fill the entry form out **COMPLETELY**, answering **ALL** of the questions. The parade committee may wish to contact you if additional information is needed.

**Who May Enter:** Any individual or organization or business.

**Deadline for Applications:** August 24, 2018 for entries to be judged. We are not responsible for entries not received.

### **Late Applications:**

Will be accepted up to the date of the parade. Late registrants will be assigned places at the end of the parade in the order received and **THEY WILL NOT BE JUDGED.**

**Report:** to the Main Street Cowboys registration table in the parking lot of the Pendleton Convention Center located at 1601 Westgate. Registration hours are between 4 PM and 8 PM on Friday, September 7<sup>th</sup>, or Saturday, September 8<sup>th</sup> beginning at 7 AM. We're requesting that all parade entrants check in at the MSC table in front of the Convention Center prior to lining up. **You must be lined up in your assigned space by 9:30 AM on Saturday.** The parade begins at 10:00 AM. When parking in the Convention Center parking lot please park in designated spaces as much as possible. This will make it much easier for all to get in and out of the lot.

**Judging:** To be judged, all entries must be in their appropriate place at the start of the parade.

**Awards:** Two sweepstakes trophies will be awarded, one by the East Oregonian and one by the Main Street Cowboys. Trophies for 1<sup>st</sup> and 2<sup>nd</sup> place will be awarded in all divisions. All Trophies will be presented at the last announcer's booth.

### **Parade Rules:**

1. Parade numbers must be visible *on both sides* of the entry nearest the front.
2. Entries should be attended at all times.
3. **PLEASE, NO CANDY THROWING!**

**DUE TO THE SAFETY ISSUES INVOLVING THE THROWING OF CANDY AND OTHER ITEMS, NO ENTRY WILL BE ALLOWED TO THROW ANY ITEMS TO THE SPECTATORS. THIS INCLUDES BUT IS NOT LIMITED TO, CANDY. GROUPS MAY PROVIDE PEOPLE TO WALK ALONG THE PARADE ROUTE AND PASS OUT ITEMS TO THE CROWD. ANY GROUPS NOT FOLLOWING THIS RULE WILL BE ASKED TO LEAVE IMMEDIATELY AND WILL NOT BE INVITED BACK.**

4. Motorized Entries reeving engines or squealing tires on the pavement will be removed from the parade immediately, for safety reasons.
5. Animal entries should be placed on **DRY FEED** 2 days prior to the parade. Riding groups are encouraged to provide their own pooper scooper.
6. The Main Street Cowboys **DO NOT** pay expenses incurred by participants.
7. **NO ALCOHOL and NO PROFANITY** along the parade route. Our parade is family oriented and we want a safe atmosphere for adults and children alike.
8. Judges' decisions are final.
9. Entries shall maintain proper spacing (**20'-30'**). Unnecessary delays in the parade may be cause for removal.
10. Discharging of firearms, loud motor noise, etc. may be hazardous or create a nuisance; entries that create such a disturbance may be removed from the parade if the safety of the crowd is endangered.
11. All entries will be evaluated for safety before receiving approval to participate.
12. Float drivers must have (2) avenues of escape. Floats must have (2) fire extinguishers at the ready.
13. Any driver/rider showing incapability to control his/her vehicle/horse will be removed from the parade.
14. All entries are required to be covered by their own insurance.
15. The Main Street Cowboys reserves the right to remove any entrant not conforming to the rules or refusing to follow the directions of the Parade Committee or Police.
16. The applicant and all persons associated with applicant's entry agree to indemnify, defend and hold harmless the Main Street Cowboys, the City of Pendleton, their officers, members and/or employees if injuries or damages of any type result to third parties from your actions.
